#### **SUBMISSION -CUM- CLARIFICATION**

It is submitted that, the "Estimated Project Cost" is **Rs 64,26,00,000/-** as per the estimate report given by the Director (Structural Engineer) "Edecons Consultants Pvt. Ltd." and signed by our Architect engaged for the Residential project "**NIDO DE AAMOR**". But at the time of submission of last clarification, inadvertently, it was mentioned as Rs.6425 lakh instead of **Rs.6426lakh**. It is a typographical error which may kindly be excused. Hence, the "Estimated Project Cost" of the project may be read as **Rs.6426lakh** instead of Rs.6425lakh as per the figure/report given by the Structural Engineer and Architect.

Secondly, as required, the "Estimated Project Cost" of the project has been corrected as Rs. 6426lakh in the respective field, as per the report submitted by the Structural Engineer and Architect. Out of which the promoter will invest Rs.2426lakh and the bank loan is Rs. 4000lakh for development of the project "NIDO DE AAMOR". The amount so obtained from the bank will be repaid after receipt of the amount from the allottees. It is submitted that the bank loan will be repaid before handing over the project to the association of allottees and allottees.
