7. POSSESSION OF THE APARTMENT:

- 7.1 Schedule for possession of the said [Apartment]: The Promoter agrees and understands that timely delivery of possession of the Apartment to the allottee and the common areas to the association of allottees or the competent authority, as the case may be, is the essence of the Agreement.
