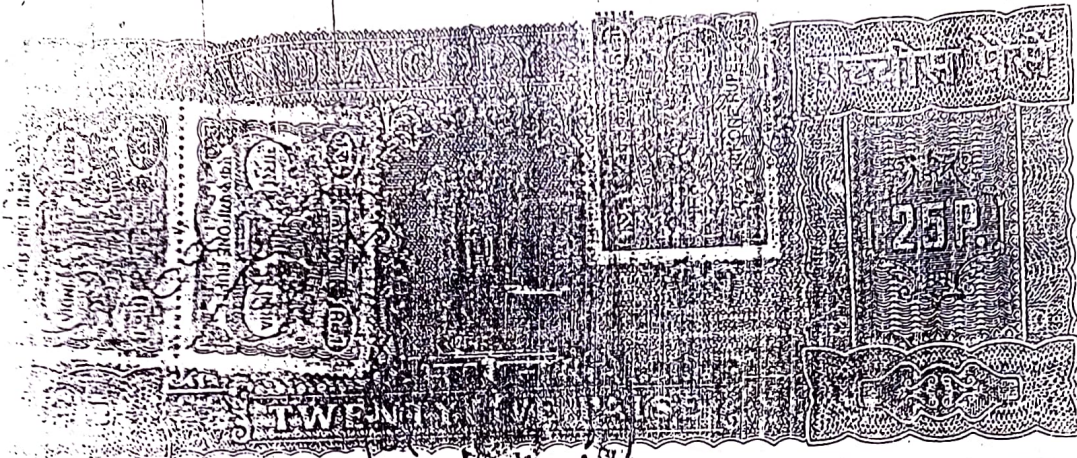

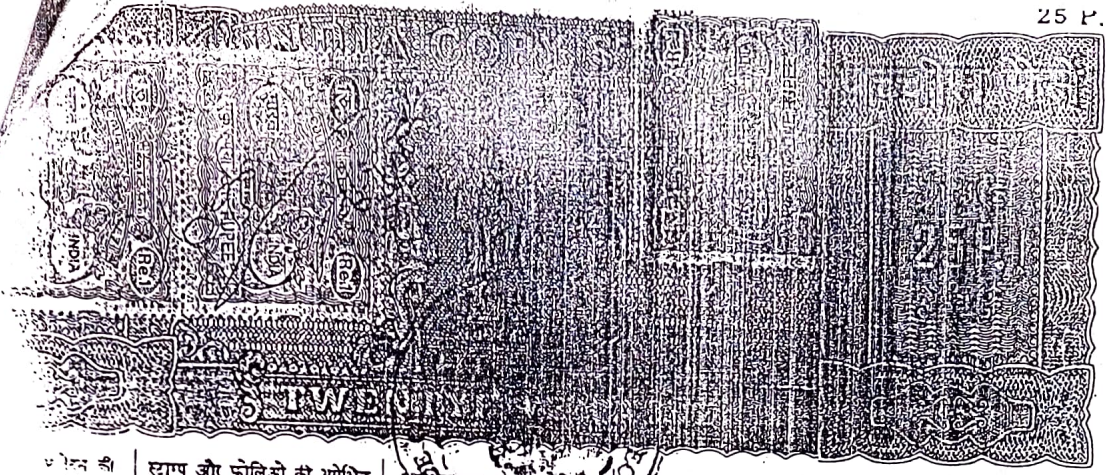

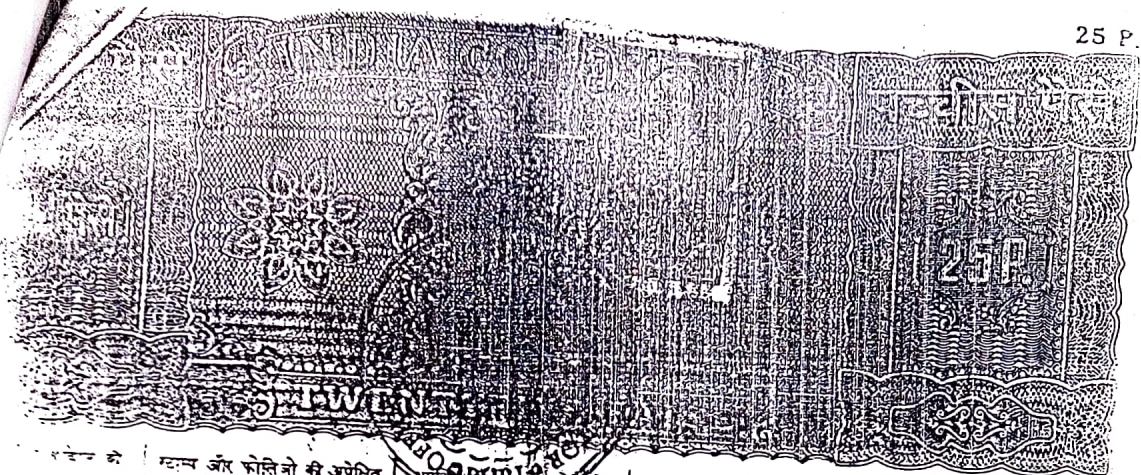

Calculated as reveals from Certified copy of the Jamabandi Register. This should have been recorded in pattadar Satwa, as because the lease of Govt land for agriculture purpose is not permanent lease. But as because lease is a matter normally dealt by normal Revenue agency i.e. Tahsil of the same has been re-examined as the Hon'ble High Court this quasi-judicial Court has nothing to do with. The said extent of land was again put in resumption vide Misc Case No. 1626/2002 dt 31.8.2002 the said lease khata No. 176/8 was dropped. Again the said khata was activated operative ex-parte orders of the Hon'ble High Court in WPC No. 12491/2008, as the resumption order was set aside by the Hon'ble Court dated 2.9.2008 on the petition of the Appellant. This is apparent from the Certified copy of the Jamabandi Register. The Computerised copy (internet) of the R.O.R. for khata No. 176/8 reveals that the R.O.R. still stands recorded.

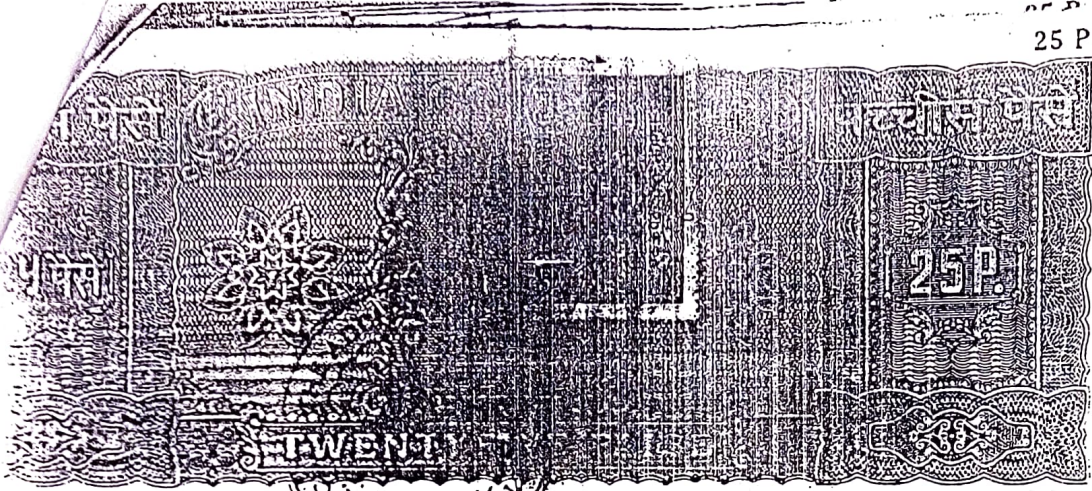

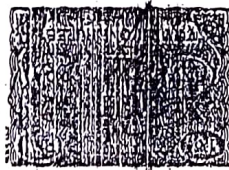

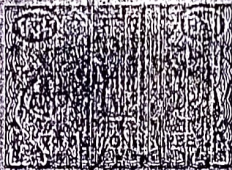
