The Promoter and Allottee shall hereinafter collectively be referred to as the "Parties" and individually as a "Party".

### WHEREAS:

The land owners are continuing to be in peaceful possession of the land A. more fully described in schedule below in respect of khata no 88 in the year 1990, it is evident that the said land was recorded in the name of Kasinath Sahoo, son of Gobinda Sahoo, Bijay Kumar Sahoo, Raj Kishore Sahu, Prasanna Kumar Sahoo, Satya Prasanna Sahoo, and Chinmay Sahoo sons of Kashinath Sahoo. The said record of right covers two plots being plot No 999 and 1388 having a total area of Ac.1.008 decimal. In the meantime the sons Rajkishore Sahu and Bijay Kumar Sahoo have departed this mortal world. In the year 1973 Biswanath Sahoo, who was the son of Gobinda Sahoo and his minor son and his wife Premalata Sahoo had jointly filed Title Suit No 140 of 1973 in the court of Sub Ordinate Judge, Cuttack, for partition against Kasinath Sahoo son of Late Gobinda Sahoo and his sons being Bijay Kumar Sahoo, Raj Kishore Sahu, Prasanna Kumar Sahoo, Satya Prasanna Sahoo and Chinmay Sahoo and mother Chandramani Dei. In the said suit a decree had been passed on the basis of the compromise petition dated 12.6.73, filed by the co owners showing allotment of specific land / plots as per the terms of the compromise petition which has been directed to form a part of the decree. And in the year 2013 Smt. Kananbala Sahoo, who is daughter of Kasinath Sahoo had filed Civil Suit No 356 of 2013 in the court of Civil Judge Senior Division First Court, Cuttack claiming a share in the joint family property which had been described as suit property. In the said suit a preliminary decree was passed on 10.2.16 declaring that the plaintiff and defendant no 1 to 4 have 1/5th share in respect of item no 1 of the property. Plaintiff and defendant no 1 to 4 have 1/10th share over item no 2 of the suit property. In the said decree it has been stated that the parties

may effect amicable partition in respect of the property described in the plaint in accordance with their defined shares. And as per the said decree passed in Title suit no 140 of 1973 as well as Civil Suit No. 356 of 2013 the present surviving land owners are Kananbala Sahoo daughter of late Kashinath Sahoo, Prasanna Kumar Sahoo, Satya Prasanna Sahoo, and Chinmay Sahoo all are sons of Late Kashinath Sahoo. The co-owner Raikishore Sahu had died on 30.12.2016 leaving behind his legal heirs and successors including wife Kalyani Sahu, daughter Bidisha Sahu and son namely Akash Sahu, who suffers from mental disability and is not competent to enter into any contract and can be represented by his mother guardian. And since then the present Executants/owners are in possession over the Schedule Land and being the absolute and exclusive owners of the said Schedule Property have full power & absolute authority to deal with the same in which ever manner they think proper and there is no impediment in the same and no third party has got any right, title, claim and interest in the Schedule Land; The owners and the promoter have entered into an [Collaboration / Development / joint development] agreement dated 23/03/2018.

- B. The Said Land is earmarked for the purpose of building a [residential] project, comprising S + 8 multistoried APARTMENT/ FLAT buildings and the said project shall be known as "Mahadev Heights";
- C. The Promoter is fully competent to enter into this Agreement and all the legal formalities with respect to the right, title and interest of the Promoter regarding the Said Land on which Project is to be constructed have been completed;
- D. The Cuttack Development Authority has granted the commencement certificate to develop the Project vide approval dated **07.03.2019** bearing letter no. **4315/CDA/Cuttack**;
- E. The Promoter has obtained the final layout plan approvals for the Project from Cuttack Development Authority. The Promoter agrees and undertakes that it shall not make any changes to these layout plans except

- (i) The Total Price above includes the booking amount paid by the allottee to the Promoter towards the [APARTMENT/FLAT];
- (ii) The Total price above includes Taxes as on date (consisting of tax paid or payable by the promoter by way of Value Added Tax, Service Tax, and Cess or any other similar taxes which may be levied, in connection with the construction of the Project payable by the promoter) up to the date of handing over the possession of the [APARTMENT/FLAT]:

Provided that in case there is any change/modification in the taxes, the subsequent amount payable by the allottee to the promoter shall be increased / reduced based on such change/modification.

- (iii) The Promoter shall periodically intimate to the Allottee, the amount payable as stated in (i) above and the Allottee shall make payment within 30(thirty) days from the date of such written intimation. In addition, the Promoter shall provide to the Allottee the details of the taxes paid or demanded along with the acts/rules/notifications together with dates from which such taxes/levies etc. have been imposed or become effective.
- (iv) The Total Price of [APARTMENT/ FLAT] includes: 1) pro share in the Common Areas; and 2) closed/open parking (s) as provided in the Agreement.
- 1.3 The Total Price is escalation-free, save and except increases which the Allottee hereby agrees to pay, due to increase on account of development charges payable to the competent authority and/or any other increase in charges which may be levied or imposed by the competent authority from time to time. The Promoter undertakes and agrees that while raising a demand on the Allottee for increase in development charges, cost/charges imposed notification / order /rule /regulation to that effect along with the demand letter being issued to the Allottee, which shall only be applicable on subsequent payments.

- 1.4 The Allottee(s) shall make the payment as per the payment plan set out in Schedule C of the Act ("Payment Plan").
- 1.5 The Promoter may allow, in its sole discretion, a rebate for early payments of installments payable by the Allottee by discounting such early payments @ 5 % per annum for the period by which the respective installment has been preponed. The provision for allowing rebate and such rate of rebate shall not be subject to any revision/withdrawal, once granted to an Allottee by the Promoter.
- 1.6 It is agreed that the Promoter shall not make any additions and alterations in the sanctioned plans, layout plans and specifications and the nature of fixtures, fittings and amenities described therein in respect of the APARTMENT/FLAT, plot or building, as the case may be, without the previous written consent of the Allottee. Provided that the Promoter may make such minor additions or alterations as may be required by the Allottee, or such minor changes or alterations as per the provisions of the Act.
- 1.7 The Promoter shall confirm the final carpet area that has been allotted to the Allottee after the construction of the Building is complete and the occupancy certificate is granted by the competent authority, by furnishing details of the changes, if any, in the carpet area. The total price payable for the carpet area shall be recalculated upon confirmation by the promoter. If there is any reduction in the carpet area within the defined limit then promoter shall refund the excess money paid by Allottee within forty-five days with annual interest at the rate specified in the rules, from the date when such an excess amount was paid by the Allottee. If there is any increase in the carpet area allotted to Allottee, the Promoter shall demand that from the Allottee as per the next milestone of the payment plan. All these monetary adjustments shall be made at the same rate per square feet as agreed in Clause 1.2 of this Agreement.

- 1.8 Subject to Clause 9.3 the Promoter agrees and acknowledges, the Allottee shall have the right to the [APARTMENT/ FLAT] as mentioned below:
  - (i) The Allottee shall have exclusive ownership of the (APARTMENT/FLAT];
  - (ii) The Allottee shall also have undivided proportionate share in the Common Areas. Since the share/interest of Allottee in the common Areas is undivided and cannot be divided or separated, the Allottee shall use the Common Areas along with other occupants, maintenance staff etc., without causing any inconvenience or hindrance to them. Further, the right of the Allottee to use the Common Areas shall always be subject to the timely payment of maintenance charges and other charges as applicable. It is clarified that the promoter shall convey undivided proportionate title in the common areas to the association of allottees as provided in the Act;
  - (iii) That the computation of the price of the [APARTMENT/FLAT] includes recovery of price of land, construction of [not only the APARTMENT/FLAT but also] the Common Areas, internal development charges, external development charges, taxes, cost of providing electric wiring, fire detection and firefighting equipment in the common areas etc. and includes cost for providing all other facilities as provided within the project.
- 1.9 It is made clear by the Promoter and the Allottee agrees that the [APARTMENT/ FLAT/Plot] along with \_\_\_\_\_ garage shall be treated as a single indivisible unit for all purposes. It is agreed that the Project is an independent, self-contained Project covering the said Land and is not a part of any other project or zone and shall not form a part of and/or linked/combined with any other project in its vicinity or otherwise except for the purpose of integration of infrastructure for the

benefit of the Allottee. It is clarified that Project's facilities and amenities shall be available only for use and enjoyment of the Allottees of the Project.

- 1.10 It is understood by the Allottee that all other areas and i.e. areas and facilities falling outside the Project, namely "Mahadev Heights" shall not form a part of the declaration to be filed with Cuttack Development Authority, Cuttack, to be filed in accordance with the Odisha Development Authorities Act, 1982/ Odisha Town Planning and Improvement Trust Act, 1956.
- 1.11 The Promoter agrees to pay all outgoings before transferring the physical possession of the APARTMENT/ FLAT to the Allottees, which it has collected from the Allottees, for the payment of outgoings (including land cost, ground rent, municipal or other local taxes, charges for water or electricity, maintenance charges, including mortgage loan and interest on mortgages or other encumbrances and such other liabilities payable to competent authorities, banks and financial institutions, which are related to the project). If the Promoter fails to pay all or any of the outgoings collected by it from the Allottees or any liability, mortgage loan and interest thereon before transferring the APARTMENT/ FLAT to the Allottees, the Promoter agrees to be liable, even after the transfer of the property, to pay such outgoings and penal charges, if any, to the authority or person to whom they are payable and be liable for the cost of any legal proceedings which may be taken there for by such authority or person.

Ltd.- Mahadev Heights, payable at Bhubaneswar,

# 3. COMPLIANCE OF LAWS RELATING TO REMITTANCES

The Allottee, if resident outside India, shall be solely responsible 3.1 for complying with the necessary formalities as laid down in Foreign Exchange Management Act, 1999, Reserve Bank of India Act and Rules and Regulations made hereunder or any statutory amendment (s) modifications(s) made thereof and all other applicable laws including that of remittance of payment acquisition/sale/transfer of immovable properties in India etc. and provide the Promoter with such permission, approvals which would enable the Promoter to fulfill its obligations under this Agreement. Any refund, transfer of security, if provided in terms of the Agreement shall be made in accordance with the provisions of Foreign Exchange Management Act, 1999 or statutory enactments or amendments thereof and the Rules and Regulations of the Reserve Bank of India or any other applicable law. The allottee understands and agrees that in the event of any failure on his/her part to comply with the applicable guidelines issued by the Reserve Bank of India, he/she shall be liable for any action under the Foreign Exchange Management Act, 1999 or other laws as applicable, as amended from time to time. 3.2 The Promoter accepts no responsibility in this regard. The Allottee shall keep the Promoter fully indemnified and harmless in this regard. Whenever there is any change in the residential status of the Allottee to intimate the same in writing to the Promoter immediately and comply with necessary formalities if any under the applicable laws. The Promoter shall not be responsible towards any third party making payment/remittances on behalf of any Allottee and such third party shall not have any right in the application/allotment of the said APARTMENT/ FLAT applied for herein in any way and the Promoter shall be issuing the payment receipts in favour of the Allottee only.

### 4. ADJUSTMENT/APPROPRIATION OF PAYMENTS

The Allottee authorizes the Promoter to adjust/appropriate all payments made by him/her under any head(s) of dues against lawful outstanding, if any, in his/her name as the Promoter may in its sole discretion deem fit and the Allottee undertakes not to object/demand/direct the Promoter to adjust his payments in any manner.

### 5. TIME IS ESSENCE

5.1 Time is of essence for the Promoter as well as the Allottee. The Promoter shall abide by the time schedule for completing the project and handing over the APARTMENT/ FLAT to the Allottee and the common areas to the association of the allottees after receiving the occupancy certificate or the completion certificate or both, as the case may be similarly, the Allottee shall make timely payments of the installment and other dues payable by him/her and meeting the other obligations under the Agreement subject to the

simultaneous completion of construction by the Promoter as provided in Schedule C ("Payment Plan").

The Allottee has seen the specifications of the [APARTMENT/ 6. FLAT/Plot] and accepted the Payment plan, floor plans, layout plans [annexed along with this Agreement] which has been approved by the competent authority, as represented by the Promoter. The Promoter shall develop the Project in accordance with the said layout plans, floor plans and specifications. Subject to the terms in this Agreement, the Promoter undertakes to strictly abide by such plans approved by the competent Authorities and shall also strictly abide by the bye-laws, FAR and density norms and provisions prescribed by the Planning and Building Standards Regulations of Cuttack Development Authority, Cuttack shall not have and an option to make variation/alteration/modification in such plans, other than in the manner provided under the Act, and breach of this term by the Promoter shall constitute a materials breach of the Agreement.

# 7. POSSESSION OF THE APARTMENT/ FLAT


7.1. Schedule for possession of the said (APARTMENT/ FLAT/Plot): The promoter agrees and understand that timely delivery of possession of the (APARTMENT/ FLAT/Plot) is the essence of the agreement. The promoter, based on the approved plans and specifications, assures to hand over possession of the (APARTMENT/ FLAT/Plot) on 10/03/2024 unless there is delay or failure due to war, flood, drought, fire, cyclone, earthquake or any other calamity caused by nature affecting the regular development of the real estate project ("Force Majeure") If, however, the completion of the project is delayed due to the Force Majeure conditions then the allottee agrees that the promoter shall be entitled to the extension of time for delivery of possession of the (APARTMENT/ FLAT/Plot), provided that such Force Majeure conditions are not of a nature which make it impossible for the contract to be implemented. The Allottee agrees and confirms that, in the event it becomes impossible for the promoter to implement the

project due to Force Majeure conditions, then this allottee the entire amount received by the promoter from the allotment within 45 days from that date. After refund of the money paid by the Allottee, Allottee agrees that he/she shall not have any rights, claims etc. against the promoter and that the promoter shall be released and discharged from all its obligations and liabilities under this Agreement.

- 7.2.
