That, the said land is free from all encumbrances.


That, the time period within which the project shall be completed by the promoter is December, 2025.

- 6. That, the amounts from the separate account shall be withdrawn by the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 7. That, the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed for such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. The promoter shall take all the pending approvals on time, from the competent authorities.
- 9. The promoter have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
