- 3. The development shall be undertaken strictly according to plans enclosed with necessary permission endorsement.
- 4. Parking space measuring 982.11 Sqm as shown in the approved plan shall be left for parking of vehicles and no part of it will be used for any other purpose and shall not be partitioned/closed in any manner.
- 5. The land over which construction is proposed is accessible by an approved means of access of 9.14 Mt (Nine point One Four) in width.
- 6. The land in question must be in lawful ownership and peaceful possession of the applicant.
- 7. The permission granted under these regulations shall remain valid up to three years from the date of issue .However the permission shall have to be revalidated before the expiry of the above period on payment of such fee as may be prescribed under rules and such revalidation shall be valid for one year.

(a) A copy of the building permit; and

(b) A copy of approved drawings and specifications.

If the Authority finds at any stage that the construction is not being carried in accordance to the sanctioned plan or is in violation of any of the provisions of these regulations, it shall notify the owner and no further construction shall be allowed until necessary corrections in the plan are made and the corrected plan is approved.
