With reference to the above cited subject and the letter under references, as per site verification over your Plot no. 3123/4838, 3118(P), 3116(P), 3121/4875, 3122/4876(P),3119, 3120/4996, 3120, 3120/4994, 3124(P), 3124/3971(P), 3120/4995, Khata No. 433/882, 433/919, 433/918, 433/1091, 433/1081, 433/1087, 433/1079, 433/1113, 433/1107, 433/108, Mouza - Sambalpur Town Unit No-12, Remed, Dist - Sambalpur, Odisha for construction of Residential Apartment Purpose, NOC is hereby issued to avail electric power supply from supply point as per the following conditions.

- If there will be any dispute regarding the ownership of the premises then the power supply will not be
- 2. The supply will not be affected unless the agreement is executed ,S/D and S/C charges fully deposited and installation of suitable rating power capacitor after completion of all departmental formalities.
- 3. You are requested to produce the documents of land, purchase voucher of the capacitor of required capacity, Electrical lay out diagram and site plan, detail particulars of motor and other applications with SI. No, rating etc., Pan Card, I.D. Proof any, Processing Fees are to be produce at the time of execution of agreement.
- 4. The agreement is to be typed in four copies on cartridge paper. First two copies are to be typed on stamp court papers of value not less then Rs 10/-. Execution of agreement can be made after clearance of arrear dues / dispute related to energy charges if any on the parties.
- The work shall be carried out by the Party/Authority through a licensed Electrical Contractor at his own cost after deposit of Net Estimated Amount and same shall be get inspected by the Electrical Inspector of Odisha at his own cost. After getting the completion certificate, clearance from Electrical Inspector & detail purchase voucher of line materials with guarantee certificate necessary supervision will be done by the WESCO representative and the line & substation will be charged.
- If any over head line / passes through the premises or electric poles are inside or adjacent to the premises before approval of your building plan ,then the over head line and electric poles are to be shifted by the Party /Authority at his own cost after all departmental formalities
- The augmentation cost will be borne by the party If any augmentation/ up gradation/ additional of existing supply system is required.
- 8. In case of any dispute arising out of this, this should not be a legal document to produce before court. This is for your kind information and necessary action.
