- 1. You have to submit necessary documents like.
 - a. Ownership of land / premises where power supply is to be provided.
 - b. Permission from the competent authority for proposed (Stilt +G+4) storied residential Building.
 - c. No objection certificate from Municipality / District Administration.
 - d. Pollution certificate from competent authority, if necessary/applicable
 - e. Any other documents required by TPSODL or by any statutory authority of Govt.
- 2. You should not have any other connection within the same premises, In case you have another connection, you have to apply in prescribed format for load enhancement with proper re-classification of category.
- 3. You have to bear all expenses toward lines, metering arrangement, & 11/0.4 KV Substation of required capacity for the above purpose for giving power supply to your said proposed (Stilt +G+4) storied residential Building (apartment) as per O.E.R.C norms in observation of all departmental formalities. You may get the work done through a Valid Electrical Licensed Contractor after approval of drawing and sanction of Estimate by the Competent Authority and deposit of necessary sanctioned amount to TPSODL. Also you have to pay the security deposit and service connection charges etc as applicable at the time of application.
- 4. Any other departmental formalities if required by TPSODL at the time of application is to be complied by you for getting power supply.

This letter is issued as an assurance for submission to Odisha Real Estate Regulatory Authority, Bhubaneswar and valid for 3months only and subject to amend as per rules of TPSODL or Govt if found necessary.
