After procurement of materials to be used for construction of 11KV line, erection of 11KV intermediate pole and installation of Substation you have to send a request letter to the S.D.O. (Elect.) Jatni with the Xerox copy of the cash memo with "Test Certificate" & "Type Test" report of materials for verification and approval of the same

Prior to taking of work, the S.D.O (Elect.) Jatni and J.M. (Elect.) No -II Jatni are to be intimated for route 5. alignment work.

The transformer should be star rated with minimum level of "No Load Losses" as specified by BEE. The 6. manufacture should be advised accordingly to produce the certificate from BEE.
