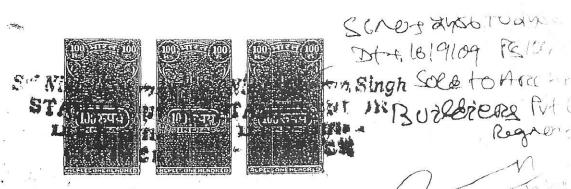

- I. The name of the Company is ARCHID BUILDERS PRIVATE LIMITED
- II. The Registered office of the company will be situated in the state of ORISSA.
- III. The Object for which the Company is established are:-

## A. THE MAIN OBJECTS OF COMPANY TO BE PURSUED ON ITS INCORPORATION ARE:-

1. To Carry on the business of builders, developers of urban and rural immovable properties, real estate agents, purchase & sale of landed properties, contractors, sub-contractors, engineers, surveyors, architects, designers. for the constructions of houses, buildings, multiplex, duplex apartments, ownership flats both residential & commercials complex, shopping godwon, sheds, factories, offices, shops, lessees of lands, hotels warehouses, roads, bridges, dam, earth works, erection, electrification, pole erection, structures, tanks, Road, bridges, railway tracks, airways, sewers. drainages, culverts, Factory sheds, Channel sewage, P. way of works, structural, iron & steel Works, Sanitary & Electrical works, supply of Manpower, labour and materials, tools, implements, machinery and all types of mechanical & civil works and to do all sorts of constructions & maintenance works for any person. company, locabaythenities uilders Pvt.Ltd Anshumis Patraik

- 2. To act as contractors and sub-contractors and to undertake, promote, design, construct, re-construct, alter, decorate, furnish and improve buildings, offices, roads, factories, warehouses, shops, schools, colleges, and in particular to promote and execute various housing schemes and complexes including row housing, ownership flats, apartments, duplex, on suitable plots of land, which may be purchased, taken on lease, in exchange of the construction as per scheme in India and abroad.
- 4. To carry on any other trade or business of a character similar or analogous to the trade or business hereinbefore mentioned or any business which may seem to the Company to be capable of being conveniently and/or profitably carried on in connection therewith, or may seem to the Company calculated, directly or indirectly to enhance the value of any of its property or rights or to further any of its objects.
- 4. 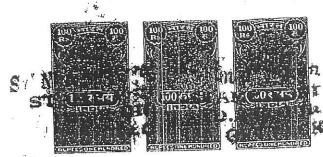

## ARTICLES OF ASSOCIATION

OF

## ARCHID BUILDERS PRIVATE LIMITED

#### 1.PRELIMINARY

- 1. Subject to any thing to the contrary hereinafter provided that regulations contained in Table 'A' in the First Schedule to the Companies Act, 1956 or any statutory modification thereof, shall apply to the Company,
- 2. In these Articles; Unless the context otherwise requires the Company or this Company means as above.

a. The words or expression contained in these Articles shall bear the same meaning as in the Act.

b. b. "The Act" means the Companies Act, 1956 or any statutory modification thereof and Section shall mean Section of the Said Act.

c. "The Seal" means the Common Seal of the Company

d. "Office" means the Registered Office of the Company.

- e. Words importing singular number shall include plural and vice versa and words importing the masculine gender shall include females and
- the words important persons shall include body corporate.

"Month" and "Year" means a Calendar Month and Calendar Year respectively.

"The Register" means the Register Members to be kept pursuant to

Section 150 of the Act.

Expressions referring to "Writing" shall be construed as including reference to printing, lithography, photography and other modes of representing or reproducing words in a visible form.

#### II. PRIVATE COMPANY

- 3. The Company is a "Private Company" within the meaning of Section 3(1)(iii) Of the Act and means a company which has a minimum paid up capital of One lakh rupees or much higher paid up capital as may be prescribed, and by its articles :-
  - (a) The right of transfer to the shares of the Company shall be restricted in the manner and to the extent hereinafter appearing these Regulations.
  - (b) The number of members of the Company Shall be limited to Fifty, not including the (I) Person who are in the employment of the Company and (ii) Persons who having been formerly in the employment of the Company were members after the employment Ceased.
  - (c) No invitation shall be issued to the Public to subscribe for any shares in or debentures of the Company.

(d) Prohibits any invitation or acceptance of deposits from persons other than its members, directors or their relatives.

Provided that where two or more persons hold one or more shares in the company jointly they shall for this purpose be treated as single shareholder.

#### III. CAPITAL

- 4. 1) The Authorised Share Capital of the Company shall be such amount as may from time to time be authorised by clause V of the Memorandum.
- 2) The Company shall have the power to Increase or reduce the capital for the time being of the Company and to divide the shares in the capital into several classes with rights, privileges or conditions as may be determined, The Company may issue preference shares which shall, or at the option of the Company shall be liable to be redeemed subject to the provisions of the Company Act, 1956.

#### IV. SHARES

- 5. The shares shall be under the control of the Board who may classify, allot, otherwise dispose of the same to such persons on such terms and conditions and either at a premium or at par or subject to the provisions of the Act at a discount and at such times as the Board thinks fit and with full power to make call for the allotment of any share either at par or at a premium or at a discount and for such time and for such consideration as the Directors may think fit. The right attached to different classes of shares may be varied in accordance with the provisions of the Section 106 & 107 of the Companies Act.
- 6. The joint holders of shares shall severally as well as jointly be liable for payment of all installments and calls due in respect of such shares,

#### V. SHARE CERTIFICATES

- 7. The certificates of title to the shares shall be issued under the seal of the Company in the manner prescribed under the rules framed under the Act. The Company shall comply with the provisions of such rules.
- 8. Every member shall be entitled to one certificate for the shares registered in his name or if the Board so approves, upon paying such fees as the Board may from time to time determine, to several certificates, for one or more of such shares,.
- 9. The certificate or shares registered in the name of two or more persons shall be delivered to the first named persons in the register and this shall be a sufficient delivery to all such holders.
- Board it may order the same to be canceled and may issue a new certificate in lien thereof, and if any certificate be lost or destroyed then upon proof to the satisfaction of the Board and on such indemnity as the Board deems adequate being given, a new certificate in lieu thereof will be given to the party entitled to being given, a new certificate in lieu thereof will be given to the party entitled to such lost or destroyed certificate. The sum of Re.1/- shall be paid to the Company for every certificate issued under this clause and the Company shall also be paid all expenses incurred in investigating evidence of loss.

11. The Board may from time to time, make such calls on uniform basis, as it think fit, upon the members in respect of all money unpaid on the shares (whether on account of the nominal value of the shares or by way of premium) held by them respectively and not be the conditions of allotment thereof made payable at fixed time and each such member shall pay the amount of every call so made on him to the person and at the time and place appointed by the Board A call may be made payable by installments.
